Dear parents/carers and families,

This week we have had quite an exciting visit from our multi academy trust and an external Health and Safety representative to do an audit. Chris Gould, our director of education for all TPAT schools, visited and was so very impressed with our maths provision in particular, curriculum and teaching across the school. He was absolutely glowing with praise for our wonderful children, the high quality of teaching and learning, and our amazing staff. Fantastic!

We are also super excited to share that we have the best audit in TPAT for our Health and Safety provision. The inspectors were so impressed they gave us the equivalent of a “Hollywood hand shake” (reference to the bake off!) We are all so proud of how hard we work to make sure that the children have the highest standard of care and safety, and this report only makes it clearer that we are delivering our wonderful motto and ethos consistently and successfully.

Health and safety is really important in schools and is closely related to safeguarding. In the recent government guidance, updated every September, the government sets out what schools must do to ensure their community is safeguarded. A huge change this year is the provision of and review of online safety. This works both ways and straddles both home and school. We have a strong curriculum offer teaching children digital citizenship, e-safety and how to behave online. As part of this children have online safety sessions, and have an acceptable use policy that we discuss and they sign up to, to make sure that we are all as safe as possible online. Staff also sign up to an acceptable use policy and the government has made it clear that best practice is for all stakeholders to sign up to these acceptable use standards, to ensure that our wider community are safe and an excellent example to others online. With this in mind, we are also sending our parent and carer acceptable use policy out for parents to sign and return. The purpose of it is to remind parents to be a good example for their children and set out what good conduct is for all of us as digital citizens. Online activity includes WhatsApp and other widely used apps that many forget are included in online safety. You will continue to get a lot of online safety information via email, and via the school newsletter. Please do keep an eye open -we are here to give help and guidance, as we know online safety can be a real nightmare to keep up to date with.
